### RULES AND POLICIES

#### **Cancellation Policy**

Refund Policy for cancellation of studio rental and/or services is as follows

• Up to eleven (11) business days prior to rental

• Between ten (10) and six (6) business days prior to rental

• Five (5) business days or less prior to rental

In the event that a renter does not qualify for a refund (based on our cancellation policy), rescheduling may be possible at the discretion of The Rentals Department. Requests for rescheduling must be received by the end of business 5 calendar days prior to the rental. No changes or refunds may be made closer than 4 calendar days to the date of use.

#### **Rules**

\*For events and receptions, a protective covering is put down to protect our dance floors at an additional cost to the renter. In this case, food, drink and street shoes are permitted in the studio.

For all other rentals, the following rules apply:

- NO food, beverages (other than water plastic bottles), glass bottles, or cans are permitted in the studios when they are being used for rehearsals, auditions or performances.
- NO chewing gum is permitted in the studios.
- NO street shoes are permitted in the studios.
- Non-dance shoes or slippers must be worn in the hallways, stairwells and elevators at all times.
- Smoking anywhere in or around the building is NOT permitted.
- Photography and Videography are not permitted anywhere in the building without prior written permission.
