2022-2023 HEALTH AND SAFETY PROTOCOLS

The Ailey School cares about the health and safety of its students, staff, faculty and musicians and has strict COVID-19 safety protocols in place. Students are expected to adhere to these guidelines at all times while inside the Joan Weill Center for Dance and at Ailey-sponsored housing facilities. All enrollment materials and proof of COVID-19 vaccination & booster are due by August 5, 2022 or students will not be allowed to enter the Joan Weill Center for Dance to commence classes. HEALTH & SAFETY REQUIREMENTS

<u>REQUIRED VACCINATION POLICY</u>: All students, staff, faculty, administration, and visitors to the Joan Weill Center for Dance must be fully vaccinated and boosted* for Covid-19 with an approved vaccine as described in the <u>Vaccine Policy</u>.
<u>Students must submit proof of vaccination & booster no later than August 5, 2022.</u>

* You must have completed a course of two doses of a two-dose vaccine, or a single dose of a onedose vaccine considered effective by the Centers for Disease Control and Prevention ("CDC") and/or the World Health Organization ("WHO"), AND have received a booster dose, when eligible.

- For example: "TerrySmith- ModernaBooster- 6-5-21"

*the date should be in the U.S. date format of month-day-year

Vaccine documentation must clearly display your name and the dates/names of all doses.

- <u>THE AILEY SCHOOL HEALTH FORM</u>: All students must submit an <u>Ailey School</u> <u>Health Form</u> that is signed or stamped by a physician. The Health Form must be emailed to <u>csabater@alvinailey.org</u> no later than August 5, 2022.
- PROOF OF HEALTH INSURANCE: Students must submit proof of health insurance coverage that is active for the duration of their summer enrollment. Proof of insurance must be emailed to <u>csabater@alvinailey.org</u> no later than August 5, 2022.

4. DAILY HEALTH SCREENING:

All students must download and register for the <u>HealthCheck by Stratum</u> app on their phone. Students must answer the app questions every morning <u>before leaving</u> <u>their home</u> to confirm that they are not experiencing any symptoms of COVID-19 and then scan the bar code upon entry to the building each day.
